## McRent Full Protection

### Travel Cancellation Insurance (for rental vehicle bookings)

Reimburses the contractually payable cancellation fees from the insured travel arrangement if the travel cannot be commenced due to an insured reason.

- + **Deductible:** 20 % of the reimbursable loss (at least € 25.00 per person).

### Travel Curtailment Insurance

(for rental vehicle bookings)

Reimburses, among other things, additional costs for the return journey in keeping with the mode and quality of the originally booked travel, if travel has to be cut short. Also reimburses the travel services unused at the destination.

- + **Deductible:** 20 % of the reimbursable loss (at least € 25.00 per person).

### Reduction of CDW Deductible Camper

Valid for camper vans, motorhomes and caravans of all types, as well as cars.

Reimburses the contractually payable and charged deductible of the collision damage insurance if the rental vehicle is damaged or stolen during the term of the insurance cover.

- + **Sum insured per rental period:** A maximum of € 1,200.00 is available.

- + **Deductible:** € 400.00 of the reimbursable damage in each loss event.

**Mode of travel:** Valid for all modes of travel – including business travel.

**Area of application:** Europe-wide (incl. Russian Federation, Mediterranean coastal states and the Canary Islands).

**Insured cost of travel:** A maximum of € 250.00 per day of rental and a maximum of € 10,000.00 per rental are possible.

**Insured duration of travel:** The insurance policies are valid for the duration of the trip (from commencement of the trip to the time of return); a maximum of 93 days is possible.

**Notes on arranging insurance:** All travel cover containing travel cancellation insurance, should be arranged at the time of booking the travel. Travel cover may be subsequently arranged up to 30 days prior to commencement of travel. If there are 29 days or less between booking and commencement of travel you must arrange the cover immediately, but no later than within the next three days. The Reduction of CDW Deductible Camper applies only when renting using the McRent program. It is possible to purchase the Reduction of CDW Deductible Camper any time before departure.

**Important information on Reduction of CDW Deductible Camper:** The deposit equal to the deductible must be paid to the rental company when taking possession of the vehicle at the location even if you purchased this supplemental German insurance! Any costs payable as part of the deductible for covered damage must always be paid directly to the rental company when returning the vehicle at the location, and must be submitted for reimbursement directly to AWP P&C S.A. and only after your return.

## McRent Reduction of CDW Deductible

### Reduction of CDW Deductible Camper

Valid for camper vans, motorhomes and caravans of all types, as well as cars. Reimburses the contractually payable and charged deductible of the collision damage insurance if the rental vehicle is damaged or stolen during the term of the insurance cover.

- + **Sum insured per rental period:**

A maximum of € 1,200.00 is available.

- + **Deductible:** € 400.00 of the reimbursable damage in each loss event.

## Important notices in the event of loss or damage

**Report the incident at once to McRent and the nearest police station at the location, and obtain the proof of reporting and the accident report.** The set deductible must be paid directly to the rental company and then submitted to AWP P&C S.A. with the following documents: proof of insurance, rental and vehicle insurance agreement and insurance policy, benefits notice from the vehicle insurer for damage, completed damage report of AWP P&C S.A., police report, confirmation from McRent of prompt damage report. **Details on what to do in the event of a claim are available in McRent's General Terms and Conditions of Business and the insurance policy of AWP P&C S.A.**
